- **Model and Design:** Smooth Cot 120x60 cm (Drømmeland - 11041570)
 - A baby bed designed for infants from 0 to 3 years old, featuring a simple and sturdy design.
 - **Compliance:** This product meets the safety and durability standards of SS716 / EN 716–1+AC:2019–07. It has been tested for durability and safety according to the latest EN standards.

2. Material Information

- **Wood Type:**
 - **Type:** Solid Pine (sourced from Polish State Forests)
 - **Additional Materials:** MDF used in the ends (panel and legs).
- **Treatment and Finish:**
 - **Lacquer:** Nitrocellulose lacquer, compliant with EN 71-3 safety standards.
- **Furniture Hardware:**
 - All screws are made of galvanized steel, manufactured in Poland.



3. Sustainability and Environmental Impact

- **Certifications:**
 - The wood is FSC-certified, sourced from Polish State Forests. FSC-STD-40-004 (BV-COC-188372)
 - **Packaging:** The packaging is made from FSC-certified paper, ensuring sustainable practices through responsible forest management. FSC-STD-40-004 (BV-COC-127176) (BV-COC-639415)
 - **Environmental Impact:**
 - Carbon emissions and water usage have not yet been evaluated.

4. Usage Instructions and Maintenance

- **Assembly and Installation:**
 - Step-by-step assembly instructions are included in the printed manual. Access the manual via the QR code on the last page.
 - Ensure all fittings are properly tightened and checked regularly, retightening as necessary.
 - **Maintenance:**
 - **Care Instructions:** Included on the last page of the manual.
 - Clean the cot using a damp cloth, followed by drying with soft, clean cloth. Avoid abrasive cleaners, bleach, alcohol, or ammonia-based products.
 - **Warranty:**
 - **Duration:** 2 years
 - **Coverage:** Covers defects not caused by improper use.

5. Recycling and End-of-Life Disposal

- **Waste Disposal:**
 - **Wood:** Can be recycled into MDF, chipboard, or biomass.
 - **Metal Parts:** Recyclable as general metal waste.
 - **Recycling Facilities:**
 - We encourage reusing the bed for additional children. Alternatively, the bed can be sold or donated. Ensure it remains in good condition and pass the manual to the new owner.
 - For recycling, disassemble the bed according to the instructions in the manual. Sort wood, MDF, and metal (screws) separately. Follow your local guidelines for recycling centers.
 - **Packaging:** Minimal plastic is used. Cardboard can be recycled as corrugated paper, while other materials should be sorted for plastic recycling. We continuously work to improve our packaging's environmental impact.

6. User Information

- **Usage Tips:**
 - The product manual contains tips for maintaining stability and durability. Keep the manual for future reference.
 - Adjust the base height in cot mode. The lowest position is the safest and should be used once the baby can sit up.
 - Suitable mattress size: 1200 mm x 600 mm. The mattress should fit tightly, with no gaps exceeding 30 mm between the mattress and the cot sides.
 - Mattress thickness: The internal height (mattress surface to upper edge of cot frame) should be at least 500 mm at the lowest base position and at least 200 mm at the highest. The maximum mattress thickness is 10 cm.
 - Avoid placing the cot too close to furniture, windows, or cords. Keep a gap of at least 300 mm from the wall.
 - The cot should no longer be used once the child is able to climb out to prevent injury.
 - **Product Registration:**
